



Next insert the WiFi DeviceLink into Slot 2 by carefully aligning the nylon retention posts and the 8-pin connector while pushing the card firmly until all posts are fully seated. Finally, reconnect the battery and AC power and verify power and WiFi LEDs are turned on.

**Configuration is automatic** and no other setup is needed besides inserting the card
